28.1 Chairman's Introduction

John Stewart welcomed everyone to the Community Council's 28th AGM. He announced that amongst those apologising for missing tonight's meeting were Sandra Blake who was in the Infirmary but was expected home in the following few days; and Lilian Graham, who was back home and recovering well from her illness.

28.2 Minutes of the last AGM

The minutes of the 2009 AGM were approved at the June 2009 ordinary Community Council meeting. The Chairman invited additional comments, but there were none.

28.3 Chairman's Report

John Stewart reviewed the past year. He thanked Robert Gatliff, Kathleen Hart and Caroline Hosking for their hard work as respectively Chair, Treasurer and joint-Secretary, and mentioned a few of the main issues that the Community Council had been involved with – mainly planning matters at such sites as the Freightliner terminal, Funpark, Scottish Power site, Newcraighall and for the new High School. He thanked PONGS and Diana Cairns for their campaign over the waste transfer site, Peter McColl for his presentation at the Viridor public enquiry, and PMAG and Caroline Hosking for their work on the North West Portobello development proposals. He also thanked Celia Butterworth and her sub-group for work on signs, plaques and the walking tour of Portobello; Peter McColl for representing the Community Council on the Neighbourhood Partnership; Dawson Currie for attending the Edinburgh Association of Community Councils for us; Sarah Potter for representing the police; our three City Councillors for their regular attendance and assistance; Cathy Cherizard of the City Council for her tireless efforts on our behalf; and various people who had organised our hustings event for the General Election.

In anticipating the coming year John was sure that further effort would be required over planning issues, and he looked forward to the reports from the Community Council's new sub-groups set up to consider local traffic problems and use of the Town Hall. He closed by thanking Margaret Munro, Sandra Blake, Diana Cairns and Nick Stroud as current office bearers.

28.4 Treasurer's Report

With Sandra Blake in hospital, Kathleen Hart presented the accounts for 2009–2010, going over detailed summaries of income and expenditure for the Community Council, Joppa Tennis Courts, and Interpretive Boards and Plaques. The balance of £3,002.25 at the bank included £1,662 'ring-fenced' for the community noticeboard at Gilberstoun. Kathleen thanked Tom and Margaret Smith for auditing the accounts.

28.5 Election of officers for 2010–2011

Stephen Hawkins took the chair for the election of the Community Council chairman. John Stewart was nominated, and with no other nominations he was elected and resumed the chair to fill the other posts. Nominations were as follows:
