# 326.5 Big Things on the Beach – 'Imagine Portobello' event, May 30th

Damian Killeen presented Big Things on the Beach's event planned for Saturday 30<sup>th</sup> May, an all day event in the Bellfield Church halls. The last 10 years has seen great growth in creative cultural activity within Portobello and Big Things on the Beach's working group are looking to connect with interested groups within the wider community of Portobello and Craigmillar neighbourhoods, to encourage their active participation in the event as a means to explore the potential of Portobello as a Creative Place.



Big Things on the Beach are keen to engage with the Portobello Community Council's Amenity space register to help examine the problem of loss of amenity space for creative use on the closure of the arts spaces and church halls.

Big Things on the Beach will use the £1500 funding to publicise the event through posters, leafleting and have set up a Facebook page. All enquiries to go to <u>enquiries@bigthingsonthebeach.org</u>.

## 326.6 Volleyball courts – update on the consultation

Lee Kindness stated that the consultation on the proposal to build permanent beach volleyball courts had concluded and the consultation had been published on the PCC website.

There had been an overall response of 158, with 92% in support and 6% against, showing overwhelming support for the proposal.

Mel Coutts stated that the council was investigating whether the proposed site of Straiton Place Park was "Common Good Land". Funding solutions were also still being sought.

ACTION : Send Mel Coutts the consultation and comments.

## 326.7 Brighton Place Setts – update on the consultation

The consultation on the Resurfacing of Brighton Place ended on Friday 20th February. Results and the report will be published on the PCC website.

The results show 48% support full sett reconstruction with 42% against. 57% support asphalt reconstruction with 36% against. 81% were against asphalt overlay.

Geoff outlined the common themes expressed in the consultation comments.

Andy Matheson of Roads Manager of CEC made apologies for Sean Gilchirst's absence. He stated that it remained the policy of CEC to retain setted streets but praised the consultation and that he will take it to the council for consideration in the decision.

There was a discussion on the state of the existing cobbles and what the council would do to prevent future setts deteriorating.

Andy Matheson stated that if full sett reconstruction was to be undertaken, new high specification jointing materials provided a higher longevity for setted roads. A robust maintenance programme and future proofing of the construction (all utilities to be fully instated prior to relaying the setts) would all help to create a stronger, more long lasting surface. Should utility companies require to dig up the setts for maintenance, a reinstatement specification would have to be followed with permits required prior to works being done.

Thea MacMillan queried what would happen to the remaining budget should setts not be the choice.

AM stated that the monies would stay within the Roads Department budget but not specific to Portobello.

Peter Bradley queried the programme of road closures and knock-on effects to the high street traders.

AM stated that the traffic management and programme of road closures had yet to be finalised but they predict two phases of works beginning January/February 2016. The first ca 37 weeks and the second ca 21 weeks avoiding the Christmas period.



John Stewart stated that he had received an email from Sean Gilchrist of CEC stating different expected lifetimes for the reinstatement options which may have impacted people's choices in the consultation.

Andy Matheson stated that he did not know why Sean Gilchrist had given contrary expected lifetimes for the construction types.

Geoff stated that the consultation was wholly based on the figures provided by Sean Gilchrist and the CEC Roads Department presented both at the previous PCC meeting and in documents sent to the PCC.

#### ACTIONS :

Peter Bradley to attend the meeting with Roads Department when decision being made. Andy Matheson to query Sean Gilchrist's conflicting information and return to PCC. CEC to advise on traffic management, project phasing and trader consultation.

#### 326.8 **Prom/Marlborough St Sign – update on the proposed replacement.**

Lee Kindness and Clare Slifer met with Celia Butterworth, John Stewart and Margaret Munro of the Signs and Plaques group to discuss the existing board's condition, content and the application for funding through the 'You Decide' community funding project.

It was agreed to meet with Paul Lambie to discuss the possibility of his input in the board's redesign. Comparative costs have been sought for the technique of printing on aluminium to progress the funding application.

A further meeting with the Signs and Plaques group and Paul Lambie is scheduled for 24<sup>th</sup> February where Paul would present his ideas for approval.

# 326.9 Portobello Station

SESTran have been in touch to say they are keen to meet to discuss the possibilities of moving forward with a plan to reopen Portobello Station and related issues.

It was suggested that Lawrence and Max would be the most logical delegation to attend the meeting (both absent).

#### ACTION : Confirm that Lawrence and Max can attend.

The public opening of the Waverley Line is proposed for September, with Brunstane one of the stations on the line connecting Edinburgh with the Borders.
