**Reprovision of the Royal Hospital for Sick Children and Department of Clinical Neurosciences at Little France**

**Invitation to attend Pre-application Consultation Meeting**

**Arthurs Seat Room, Post Graduate Education Suite at the Royal Infirmary of Edinburgh  
Thursday 1 May 2014 – 7pm to 9pm**

As you may be aware on April 5 2012 the City of Edinburgh Council granted Planning Permission in Principle to NHS Lothian for the re-provision of the Royal Hospital for Sick Children (RHSC) and the Department of Clinical Neurosciences (DCN) in car park B at the Royal Infirmary of Edinburgh (Ref: 11/02454/PPP).

During the course of 2013 NHS Lothian held a competitive dialogue with three consortia for the design, construction and operation of the new healthcare facility. In March 2014 NHS Lothian identified Integrated Health Solutions Lothian as the preferred bidder for the project.

Integrated Health Solutions Lothian are currently finalising the architectural and landscape design proposals for the RHSC + DCN with the intent of submitting a Matters Specified in Conditions application and a local planning application to the Council for approval in May 2014.

Prior to lodging these applications NHS Lothian will hold a pre-application consultation meeting in the **Arthurs Seat Room at the Royal Infirmary of Edinburgh on Thursday 1 May 2014 from 7pm to 9pm.**

You are invited to attend this event which will provide detailed design proposals and construction methodology for the RHSC + DCN. Representatives of NHS Lothian and Integrated Health Solutions Lothian will be on hand to answer your questions and you will have the opportunity to record your views.

It should be noted that comments made at this meeting are not representations to the planning authority. There will be an opportunity to comment or make representations directly to the Council once the two applications have been lodged with the planning authority.
